## TERMS AND CONDITIONS "PROMOTION - HANDLE FOR 1 EURO CENT"

## I GENERAL

- The entity responsible for the organization of the promotion is PORTA KMI POLAND Spółka Akcyjna in Bolszewo at 54 Szkolna Street, 84-239 Bolszewo, entered into the register of entrepreneurs of the National Court Register kept by the District Court for Gdańsk-Północ in Gdańsk, VIII Commercial Division of the National Court Register under KRS number 0000 838 758 with NIP: 5850006204, REGON: 190542423, share capital of PLN 125,704,899, fully paid (hereinafter referred to as the "Organizer").
- 2. The promotion is organized under the name **"PROMOTION HANDLE FOR 1 EURO CENT"** and is hereinafter referred to as the **"Promotion".**
- 3. The promotion starts on March 11. 2024 and ends on December 31, 2024 (the "Promotion Period"). It may end earlier if the stock of the products included in the Promotion is exhausted.
- 4. The promotion is organized in the, Lithuania in stationary and online stores, the detailed location of which can be found on the Organizer's website www. portadoors.com
- 5. The Promotion is addressed by the Organizer to the entities listed in point 4 above. The entities implementing the terms and conditions of the Promotion in relation to the Participants are the entities listed in point 4 above ("Dealers").
- 6. The promotional list price is the maximum price suggested by the Organizer. The final amount of the promotional price for the Participant depends on the entity listed in point 4 above.
- 7. The Promotion may be used by any natural person (hereinafter referred to as the "Participant") placing an order for a purpose not directly related to their business or professional activity, who jointly meets the following conditions:

a) during the Promotion Period, he/she purchases the doors covered by the Promotion,

b) resides in the territory of Lithuania, Latvia, Estonia, UK.

- 8. The person referred to in point 7 above who buys a door from the collections covered by the promotion (listed in point 8 c below) during the Promotion Period will be able to take advantage of the promotional price set by the entity listed in point 4 above for the handle under the following conditions:
  - a) the promotion applies only to internal doors purchased by the Participant in a set consisting of: a door leaf and a dedicated frame,
  - b) in order to take advantage of the Promotion, the purchase must concern internal doors, and the choice will be made only from among the products indicated by the Organizer on the Organizer's website: <u>www.portadoors.com/</u> promotion or in the PORTA 2024 Catalogue. - c) Door collections, the purchase of which entitles you to take advantage of the Promotion, are:

- d) the Promotion includes the possibility to buy one set of handles of your choice for each price of door leaf and its frame:

  - Segura handle black or silver
  - Doro handle black or silver

together with the rosette of your choice (to choose from: key lock escutcheon or euro cylinder escutcheon or WC escutcheon ), for **1 EURO CENT**" for the above-mentioned collections.

9. In order to take advantage of the Promotion, it is necessary to notify the seller in the selected store of the intention to make a purchase under the Promotion, before placing a formal order.

## II FINAL PROVISIONS

- 2. The Organiser is entitled to amend the provisions of these Terms and Conditions, provided that this does not affect the deterioration of the conditions of participation in the Promotion.
